Award Description The CDBG-R grant to Richland County Government has been committed to three activities. \$197,000 will be used to pave 1800 linear feet of dirt road. This project will impact 28 new homeowners who participated in a Habitat for Humanity housing blitz. \$55,000 was committed to the Urban Leagues Youth Leadership Development Institute for a year round career, academic and personal development training program for 25 participants. The program has a employment component where each participant will be placed in a professional job setting for the summer of 2010 and received a stipend. Workshops, field trips and classroom instruction will be provided during the 2010/2011 academic year. The 3rd activity funded by this grant is in-fill housing development in a neighborhood targeted for

revitalization. \$79,569 will be leveraged with other funding sources (CDBG, NSP-1, HOME Match and program income) to construct 3-4 single family homes and acquire and rehabilitate 1 foreclosed property. This project will have a great impact on the community: it will provide affordable homeownership opportunities for low to moderate income families; it will remove abandoned and unkempt vacant lots which previously occupied a dwelling and now pose a threat to the communities property value and safety and also the project will help to remove the stigma of being an undesirable community to live.

Finally a Career Cruising program was launched. Youth were also required to submit an essay to compete for a cash prize. Also during this quarter The infill housing project to build homes on vacant lots is underway and working simutaniously through other activities to replace homes that have been demolished over the years. This quarter two parcels were purchased and will be the location for single family new construction. Improvement of housing stock in Ridgewood will have a positive impact on property values and will provide decent, safe and affordable housing in the neighborhood. Last quarter we reported that the infrastructure project was completed.
