

1. CALL TO ORDER - Chair Barron called the meeting to order at approximately 3:00 PM.

Another individual's qualifications were close, but they are an "outsider". He inquired if we would be better served by the "outsider" with good qualifications versus the individual that is "in-house".

Ms. Barron responded the position would be better served by someone that does not work in tandem with the Community Relations Council. She inquired as to what further benefit the board would garner from appointing this individual.

Mr. Malinowski moved to appoint Dr. Sybil Rosado, seconded by Ms. Barron.

Mr. Malinowski stated the qualifications, responses, and professionalism of Dr. Rosado are equal to

Ms. Kabrina Bass, but he thought Dr. Rosado was a better candidate.
