Purpose(s)/Service(s): The Midlands Workforce Development Board (MWDB) is the administrative entity of the US Department of Labor program known as the Workforce Innovation and Opportunity Act (WIOA). The program is designed to strengthen and improve our nation’s public workforce system and help get Americans, including youth and those with significant barriers to employment, into high-quality jobs and careers and help employers hire and retain skilled workers.

The MWBD, by federal mandate, must be composed on more than that 50% private sector business leaders. Board members are appointed to specific seats by County Councils – Richland **TWELVE** (12), Lexington **EIGHT** (8), and Fairfield **THREE** (3). Richland County seats are comprised of **SEVEN** (7) private sector business, with **ONE** (1) representing Apprenticeship programs; **THREE** (3) education (One Midlands Technical College, One Adult Education & Literacy), **ONE** (1) Economic Development and **ONE** (1) SC Department of Employment & Workforce. Members shall not serve more than **TWO** (2) consecutive terms; however, upon service of **TWO** (2) consecutive terms a member may be eligible for reappointment after **ONE** (1) year of non-service.

The Board meets quarterly on Thursdays at 10:30 AM at 100 Executive Center Drive, Columbia – Suite 218 and last approximately an hour. Each meeting date is selected at the conclusion of each meeting. Virtual attendance options are available.
