# **Report of the County Administrator**

- a. Clarification of EMS Stations Budget Amendment: Mr. Pope previously clarified for Mr. Malinowski the change in dollar amounts from first reading to second reading. No other Council members had questions regarding the item.
- b. Farmers' Market Update: Mr. Pope stated that the revised joint resolution is in the agenda packets. He also stated that a letter is ready Mr. McEachern's signature regarding the Legislative Delegation's support of Representative Bales' amendments to the resolution. ACTION:
