Council approved the implementation of a Commercial, Industrial and Office Plans Review Fee Schedule, effective July 1, 2002 based on the following schedule:

Initial Fee \$200.00

< 5,000 sq. ft. \$200.00 + 0.20 per sq. ft. 5,001 - 50,000 sq. ft. \$200.00 + 0.10 per sq. ft. > 50,000 sq. ft. \$200.00 + 0.05 per sq. ft.

Council approved the following changes to the Solid Waste Fee Schedule, effective July 1, 2002:

- a. Add a one-time Roll Cart fee of \$39.00.
- b. Increase Solid Waste collection fee to \$139 for all Solid Waste Customers.
- c. Increase the Tire Tipping Fee to \$100.00 per ton.
- d. Eliminate the exemption to municipalities for tipping at the C&D Landfill. Charges will be the same as the current fee schedule for all other patrons.
- e. Implement and enforce fees for commercial use at the Lower Richland Drop-off Site.
