- d. DHEC Early Action Compact to Improve Air Quality Council approved a request for Richland County to sign an Early Action Compact in order to defer non-attainment designation. ACTION:

- e. Mid-East Road Rights-of-Way Council approved the condemnation of rights-of-way of the property of five residents of Mid-East Road in order for Mid-East Road to be paved and the cost of rights-of-way for an amount determined by the Court, but projected to be \$11,183. ACTION: LEGAL/PUBLIC WORKS
- f. Solid Waste Professional Service Council authorized staff to negotiate and award a contract for solid waste consulting services. ACTION:

Easements for Richland Memorial Hospital Family Practice Center Council gave first reading approval to the request to grant two utilities easements: one to SCE&G and one to the City of Columbia for Richland Memorial Hospital in order to supply permanent electric and gas meters, as well as water and sewer to the new Family Practice Center. - Richland School District One: Disposal of Property Council approved a. the transfer of the Sarah Nance Elementary School from Richland School District One to the City of Columbia Parks and Recreation Department and Burton Elementary School to the City of Columbia. **ACTION**: **LEGAL**

- EMS: Ambulance Remount Contract Council approved the e. ambulance remounting contract extension to Professional Fabrication to remount five (5) ambulance patient modules and not to exceed the budgeted amount of \$95,000. ACTION: EMS/PROCUREMENT/FINANCE/BUDGET
