DIRT ROAD PAVING CONTRACTS UPDATE

- a. **Package B Dirt Road Paving Contract** – Peafowl Drive, Prestley Drive, Ted Street, Harold Street, India Street, Pilgrim Road, Tammy Drive, Ethels Avenue, and Townsend Street have all been paved.

On October 7th, Council approved the relocation of waterlines William Duffie Road. Once the waterline relocation has been completed, work will restart.

- b. **Package C Dirt Road Paving Contract** – Cedar Grove Road, Tiger Paw Lane, Cheek Street, Clayton Street, Griggs Street, Polk Street, Sarah Street, Christy Creek Lane, Annie Entzminger, Cliff Anderson Road, Winterwood Court, and Zachary Lane should be completed by November 21st.
- c. **Package D Dirt Road Paving Contract** – Notice to proceed was issued to Lane Construction on August 13th. Paving of Overlook Drive, Dune Point, and Boylston Road should be completed before Christmas.
- d. **Package E Dirt Road Paving Contract** – The bid opening was conducted on November 4th and there were 4 responsive bidders.

The lowest bidder was C. R. Jackson. The contract will be on the November 18th Council agenda for approval.

The larger contractor are able to pave in the “off season” since they are able to produce their own asphalt.

DIRT ROAD PAVING TEAM LIMITED NOTICE TO PROCEED CONTRACT

- a. Scope of Work** – The Dirt Road Paving Team will conduct public outreach meetings, design Joster Street, and “clean up” the dirt road database.
