Richland County Council Request for Action

Subject: Amendment to County Code of Ordinances (Purchasing)

A. Purpose

County Council is requested to consider an amendment to the County Code that would allow for greater flexibility for County Council to act outside the parameters of the Purchasing Ordinance when Council finds the situation merits such action.

B. Background / Discussion

The County Code (Section 2-590 et seq.) in its present form delineates a strict set of procedures for the competitive bidding process. In recent months, several occasions have arisen where it appears that County Council could have benefited from discretion from the rigidity of the present ordinance. In furtherance of that goal, we have drafted an amendment to the County Code which would allow County Council to contract outside of the Purchasing Ordinance if an ordinance is passed specifically expressing the intent to do so. This amendment would allow for greater flexibility in certain situations while also providing for checks and balances in the form of the ordinance process.

C. Financial Impact

STATE OF SOUTH CAROLINA COUNTY COUNCIL FOR RICHLAND COUNTY ORDINANCE NO. ___-07HR

AN ORDINANCE AMENDING THE RICHLAND COUNTY CODE OF ORDINANCES, CHAPTER 2, ADMINISTRATION, ARTICLE X, PURCHASING; DIVISION 2, COMPETITIVE PURCHASING POLICY; SECTION 2-598, GENERAL PROVISIONS; SUBSECTION (A); SO AS TO EXEMPT CERTAIN CONTRACTS FROM THE COUNTY'S REQUIREMENTS UNDER THIS ARTICLE.

Pursuant to the authority granted by the Constitution and the General Assembly of the State of South Carolina, BE IT ENACTED BY THE COUNTY COUNCIL FOR RICHLAND COUNTY:

SECTION I. The Richland County Code of Ordinances, Chapter 2, "Administration", Article X, "Purchasing", Division 2, "Competitive Purchasing Policy"; Section 2-598, General Provisions; Subsection (a); is hereby amended by the deletion of the language contained therein and the substitution of the following language:

Sec. 2-598. General Provisions.

(a) All public purchases shall be made in a manner which provides for the greatest economy for the taxpayer, the fairest selection of vendor, and the prevention of conflicts of interest. Towards this end, it shall be the policy of the county that, whenever practical, leases, goods, and services required by county agencies shall be procured through a competitive purchasing policy which may be achieved through competitive bidding or through requests for proposals; provided, however, contracts that are specifically approved by a county ordinance are exempt from the provisions of this Article.

Professional services shall be procured as set forth in section 2-600 of this Code, unless otherwise prohibited by law.

The method of contracting known as "design/build" wherein the successful vendor shall perform a "turnkey" project to include all architectural, engineering, construction and other services necessary to provide a complete facility, is expressly authorized. The contractor shall identify the architects and engineers he proposes to use in his bid or proposal and shall coordinate all activities of said architects, engineers, designers, subcontractors, suppliers and others involved in the project to provide a completed facility meeting contract requirements, and shall insure compliance with all other applicable county, state or federal laws. When the "design/build" concept is utilized through competitive bidding or requests for proposal, then the requirements that architectural and engineering services be procured under section 2-600 of this division shall be waived.

The "design/build" method of contracting shall only be employed when the county council determines that the utilization of such method is in the best interest of the county.

<u>SECTION II.</u> <u>Severability.</u> If any section, subsection, or clause of this ordinance shall be deemed to be unconstitutional or otherwise invalid, the validity of the remaining sections, subsections, and clauses shall not be affected thereby.

<u>SECTION III.</u> <u>Conflicting Ordinances Repealed.</u> All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION IV. Effective Date. This ordinance shall be effective from and after _____, 2007.

Richland County Council Request of Action

Subject: Ordinance amendment that would add the Probate Judge to the list of elected officials who receive a re-election salary increase at the time the new term of office begins.

A. Purpose

The County Council is requested to approve an ordinance amendment that would add the Probate Judge to the list of elected officials who receive a re-election salary increase at the time the new term of office begins.

B. Background / Discussion

In 2000, the County Council adopted a pay plan for elected officials, to include annual salary increases, because the County's elected officials are not covered by the Performance Enhancement Program (PEP) by which all other County employees receive pay increases. The elected officials' pay plan includes the Auditor, Treasurer, Clerk of Court, Coroner and Sheriff, and provides for annual increases equal to the Consumer Price Index (CPI) for the year the increase is given. The plan further calls for an additional 5 percent increase upon the re-election of each elected official included in the plan.

The Probate Judge was not included in the plan because, as provided by State law, the Probate Judge's salary adjustments track State employee salary increases each year, which are determined by the State. The Probate Judge has requested, however, that her position should be included in the elected officials pay plan, but only for the 5 percent increase upon re-election to office. The Probate Judge has further requested that the inclusion of her position, if approved by the Council, be made retroactive, meaning that she would receive two 5 percent increases, one for her re-election in 2002 and one for her re-election in 2006.

C. Financial Impact

The cost to include the Probate Judge in the elected officials pay plan, for re-election increases only, and to make the application of the plan retroactive is approximately \$17,000. If the plan is not applied retroactively and is applied from this year (2007) forward, the cost is approximately \$4,400.

D. Alternatives

The following alternatives should be considered:

- 1. Approve the request to include the Probate Judge in the elected officials pay plan, for reelection increases only, and apply the plan retroactively.
- 2. Approve the request to include the Probate Judge in the elected officials pay plan, for reelection increases only, but not apply the plan retroactively.
- 3. Do not approve the request to include the Probate Judge in the elected officials pay plan.

E. Recommendation

It is recommended that the Council approve alternative 1, i.e., approve the request to include the Probate Judge in the elected officials pay plan, for re-election increases only, and apply the plan retroactively.

STATE OF SOUTH CAROLINA COUNTY COUNCIL FOR RICHLAND COUNTY ORDINANCE NO. ___-07HR

AN ORDINANCE AMENDING THE RICHLAND COUNTY CODE OF ORDINANCES, CHAPTER 2, ADMINISTRATION; ARTICLE VI, ELECTED AND SPECIAL OFFICERS; SECTION 2-262, SALARIES OF CERTAIN ELECTED OFFICIALS; SO AS TO PROVIDE FOR THE SALARIES OF SUCH OFFICIALS AND FOR SUBSEQUENT PAY INCREASES.

Pursuant to the authority granted by the Constitution and the General Assembly of the State of South Carolina, BE IT ENACTED BY THE COUNTY COUNCIL FOR RICHLAND COUNTY:

<u>SECTION I.</u> The Richland County Code of Ordinances, Chapter 2, Administration, Article VI, Elected and Special Officers, Section 2-262, "Salaries of Certain Elected Officials," is hereby amended to read as follows:

Sec. 2-262. Salaries of certain elected officials.

(a) This section shall apply to the following elected officials: auditor, clerk of eourt, coroner, sheriff, and treasurer. These officials shall be excluded from the County's pay and classification plan: auditor, clerk of court, coroner, probate judge, sheriff, and treasurer.

(b) The salary of the auditor, clerk of court, coroner, sheriff, and treasurer shall be determined through the County's budget process, and does not include any supplemental appropriations from the state of South Carolina or from any other source.

(c) Each year <u>the</u> elected officials <u>listed in (b)</u>, <u>above</u>, shall receive a pay increase commensurate with the percentage increase of the Consumer Price Index (CPI) over the previous year, which number is distributed to the County from the State Department of Revenue through the South Carolina Association of Counties for budgetary purposes, but not to exceed 4% for that year; provided, however, elected officials' salaries shall be reviewed at the same time that other County positions are reviewed for market comparisons, but in no event longer than three years. If it is determined that an elected official's salary is higher than others surveyed in similar sized counties, the elected official shall not receive a CPI pay increase for the first year following such review. Pay increases, when applicable, shall take effect starting with the first pay period in July.

(d) Upon re-election, the elected officials listed in (a), above, shall receive a 5% pay increase, which shall take effect at the beginning of the new term of office.

(e) A newly elected official, or an individual appointed to fill an existing term of office, shall receive the salary of the previous incumbent, but shall not receive the 5% pay increase that re-elected officials receive.

<u>SECTION II.</u> <u>Severability.</u> If any section, subsection, or clause of this ordinance shall be deemed to be unconstitutional or otherwise invalid, the validity of the remaining sections, subsections, and clauses shall not be affected thereby.

<u>SECTION III.</u> <u>Conflicting Ordinances Repealed.</u> All ordinances or parts of ordinances in conflict with the provisions of this ordinance are hereby repealed.

SECTION IV. Effective Date. This ordinance shall be enforced from and after _____, 2007.

Graffiti Abatement Program (GAP)

The Richland County Sheriff's Department (RCSD) requests \$25,000 to implement a graffiti removal, education, and enforcement program in Richland County. Graffiti trashes our community, and when left unmonitored, becomes prevalent. Various communities have gang activity, and graffiti is a problem. Graffiti lowers property values, invites criminal activity beyond the vandalism, and ultimately lowers the economic health of our community. Furthermore, certain types of graffiti contain messages and threats from gang members. This and all other types of such vandalism need to be documented and removed as soon as possible. We will educate our communities about graffiti, tagging, and vandalism through an educational component that will be used for presentations to churches, schools, and community organizations. Our agency will enforce the laws regarding the defacement of private and public property to the fullest extent of the law, so citizens will know the consequences of these actions.

Program implementation requires a trailer with a mounted, heated, belt- driven pressure washer, a water tank, paint and paint removal supplies, paint accessories such as rollers and gloves, one high powered pressure washer, and graffiti/gang educational DVDs (totaling approximately \$25,000). There are no personnel costs are associated with this program funding request. The Community Action Team and the Gang Unit of the Richland County Sheriff's Department will be the primary leaders of this project, and will utilize the Richland County Sheriff's Department's volunteer alumni association for project implementation, The proposed project period is January 1, 2007 through June 30, 2007. The equipment and educational supplies will be ordered and received by March 2007. Abatement and educational presentations will start no later than April 2007 and continue throughout the project period with a June 30, 2007 end date. Documentation will be maintained of educational presentations and abatement during the project period, and a final report will be submitted to the State of South Carolina through the Budget and Control Board before the end of June 2007.
