The vote in favor was unanimous.

John Hardee Express Way Project Funding – Mr. Rose moved, seconded by Ms. Hutchinson, to forward this item to Council with a recommendation to approve the funding request resolution and to also add Representative Joe Wilson to the resolution. The vote in favor was unanimous.

**Review of the Comprehensive Plan to ensure consistency** – Mr. Malinowski moved, seconded by Ms. Hutchinson, to forward this item to Council with a recommendation to approve the recommendation to direct staff to review the Comprehensive Plan. The vote in favor was unanimous.

**Broad River Sewer Monthly User Fees** – Mr. Malinowski moved, seconded by Ms. Hutchinson, to hold this item in committee to obtain additional information from the County's Utilities Department and City of Columbia. The vote in favor was unanimous.

<u>Community Residential Care Facility Resolution to Richland County Legislative</u> <u>Delegation and SC General Assembly</u> – Mr. Rose moved, seconded Ms. Hutchinson, to forward this item to Council with a recommendation to approve submittal of the resolution to the Richland County Legislative Delegation, in conjunction with the South Carolina General Assembly. The vote in favor was unanimous.
