

Richland County Council Rules and Appointment Committee MINUTES

1. CALL TO ORDER - Chairwoman Gretchen Barron called the meeting to order at approximately 4:10 PM.

2. APPROVAL OF MINUTES

a. May 7, 2024 - Mr. Weaver moved to approve the minutes as distributed, seconded by Ms. Terracio.

The vote in favor was unanimous.

3.
