1. **CALL TO ORDER** - Mr. Malinowski called the meeting to order at approximately 4:00 PM.

2. APPROVAL OF MINUTES -

a. November 16, 2021 – Ms. Barron moved, seconded by Ms. Mackey, to approve the minutes as distributed

INTERVIEWS

He noted the previous candidates they interviewed are eligible to be appointed to the board, and the applicants being interviewed today will be eligible to be appointed when the next vacancies come up.

Ms. Mackey moved, seconded by Ms. Barron, to go into Executive Session to interview the applicants.
