

## PUBLIC NOTICE OF CANDIDATE FILING AND PRIMARY

### Candidate Filing Period:

A special candidate filing period for South Carolina State Senate District 19 in Richland County will open at noon on Friday, September 1, 2023, and close at noon on Saturday, September 9, 2023. (*Closed Labor Day Weekend, September 2-4*)

### Filing Locations:

Any candidate seeking a political party's nomination for this office must file during this period with either the Richland County Board of Voter Registration and Elections or the State Election Commission.

Filing Form: The Statement of Intention of Candidacy & Party Pledge (SICPP) form required for filing is available in the "Candidate Information" section of [scVOTES.gov](http://scVOTES.gov) and at the county voter registration and elections office.

Filing Fee: The filing fee for this office is \$100.00. Filing fees are paid at the time of filing by candidates seeking the nomination of a party nominating by primary. Filing fee checks should be made payable to the appropriate state political party. A candidate seeking the nomination of a party nominating by convention does not pay a filing fee.

State Ethics Filings: Candidates are required to file a Statement of Economic Interests and a Campaign Disclosure online with the State Ethics Commission at <http://ethics.sc.gov>. Failure to file these documents may result in a candidate fine but will not disqualify a candidate from the election. Contact the State Ethics Commission for more information.

Notice of Primary:

If at the close of filing a party primary is necessary to determine the party nominee (multiple candidates file for one party's nomination), a primary will be held on Tuesday, October 24, 2023. Any necessary runoffs will be held on Tuesday, November 7, 2023.

Any person wishing to vote in these primaries and runoffs must be registered in person by Friday, September 22, 2023, by 5:00 p.m. at the Richland County Voter Registration Office. Voter registration online, by fax, or by email must be entered no later than Sunday, September 24, 2023, at 11:59 pm. Voter registration by mail forms will be accepted if postmarked no later than Monday, September 25, 2023.

The special election for this office will be held on January 2, 2024.

The early voting period for primary election (if necessary) begins on Monday, October 9, and ends on Friday, October 20. In the event of a primary runoff election, the early voting period will be Wednesday, November 1 to Friday, November 3. The following Early Voting Center will be open during the early voting period from 8:30 a.m. until 5:00 p.m., Monday through Friday (closed Saturday and Sunday):

Voters will be asked to provide one of the following Photo IDs when voting in person.

S.C. Driver's License

- Includes standard License and REAL ID
- S.C. Department of Motor Vehicles ID Card
  - Includes standard ID card and REAL ID
  - Includes SC Concealed Weapons Permit
- S.C Voter Registration Card with Photo
- Federal Military ID
  - Includes all Department of Defense Photo IDs and Veterans Affairs Benefits Card
- U.S. Passport
  - Includes US Passport ID Card

If you have one of these Photo IDs, you are ready to vote. Voters should remember to bring one of these IDs with them to the polling place. Voters without Photo ID can get one free of charge from the Department of Motor Vehicles or their county voter registration office. Voters who encounter an

obstacle to getting a Photo ID should bring their paper voter registration card without a photo with them to their polling place. These voters can then sign an affidavit swearing to their identity and to their obstacle to obtaining a Photo ID and vote a provisional ballot. This ballot will count unless the county board of voter registration and elections has grounds to believe the affidavit is false. At 9:00 a.m. on the day preceding the primary (if needed), the day the runoff (if necessary), the Richland County Board of Voter Registration and Elections will begin its examination of the absentee ballot return envelopes at the Voter Registration and Elections Office, 2020 Hampton Street, Columbia, SC, 29204.

If a primary election is held, the Richland County Board of Canvassers will convene on Thursday, October 26, 2023 at 11:30 a.m., to determine the validity of all provisional ballots cast in the primary. If a runoff election is necessary, on Thursday, November 9, 2023 at 11:30 a.m., the Richland County Board of Canvassers will hold a hearing to determine the validity of all provisional ballots cast in the runoff. These hearings will be held at the Richland County Administration Building, 2020 Hampton Street, Columbia, SC, 29204.

The following precincts and polling places will be open from 7:00 a.m. until 7:00 p.m. during any necessary primaries and runoffs. Always check your polling place at [scVOTES.gov](http://scVOTES.gov) before leaving to vote in any election.
