Previous Meetings Minutes

The minutes of the previous meeting held on January 8, 2024 were presented for approval. The minutes were approved by a unanimous vote.

Meeting Agenda Distribution

A meeting agenda was distributed and presented by Airport General Manager Peter Cevallos. The agenda was unanimously approved.

Chairman's Report / Executive Committee Report

No report provided

Operations & Facilities Committee Report

Commissioner Dessau provided a report on Airport Operations & Facilities.

Promotional Committee Report

Commissioner Hutto led a discussion about the BLAST Program. This is a program that she would like to promote to get school aged children involved in. She would also like to get the FAA involved and perhaps provide some funding for this program.

Commissioner Hutto informed the Commission that WA Perry School is having an Aviation Day event and would like to have someone represent the Airport at that event. She would like to involve the Chamber of Commerce and have them include the airport in promotional campaigns.

Airport General Manager's Report

Mr. Cevallos briefed Airport Operations for the month of January 2024 was 526 take-offs and 542 landings; for February 2024, 778 take-offs and794 landings; and for the timeframe of August 2023 to February 2024, 4,076 take-offs and 4,161 landings. Mr. Cevallos recognized Ms. Peggy Roberson, with Eagle Aviation, who provided the fixed base operation activity report. Mr. Cevallos shared the Operating Budget Status for the Airport through February 2024: Airport Revenue was at \$198,230.93, with Personnel expenditures \$96,386.18, Operations expenditures \$160,037.06, Capital expenditures \$143,171.40, and Total expenditures \$399,594.64.

Mr. Cevallos briefed the Taxilane Pavement Rehabilitation (Design) project status is the airport consultant is continuing work on the project design, with surveying and pavement coring being recently conducted. For the Rotating Beacon Replacement Project, the beacon tower is on order, with anticipated delivery date for the tower and its installation set for mid-summer (July/August) 2024.

Mr. Cevallos provided follow-up on two items from the January 8 Commission meeting. He shared the Mardi Gras Festival organized by City Roots Farm and held February 10, created an access impact to two airport activities that were simultaneously being conducted at the Airport that same day. He stated that he would look to ensuring better communications and coordination between the events that could occur around and on the airport. Mr. Cevallos briefed that the filming of SCETV educational TV show "The Cool and the Strong," occurred on the Airport on January 18th. He shared that two of the Airport's based tenants participated in the filming, James Clark and John Parrish, who lent their aircraft for the film shoot and provided technical assistance to the episode. He stated filming was conducted in one day and successful, and that the SCETV staff was very appreciative of everyone's contribution. Commissioner Parrish also shared his perspective.

Mr. Cevallos stated that he, along with Airport Commission Chair Kelly, Commissioners Hutto, Dessau, and Barrineau, represented the Airport at the 2024 SC Aviation Association Annual

Conference held February 14-16, 2024 at the Marriott Grande Dunes in Myrtle Beach. The conference was attended by over 350 industry members including the FAA, SC Aeronautic Commission, other state airport representatives, consultants, and industry vendors.

Mr. Cevallos briefed Richland County Council gave final approval for Chapter 3 of the Richland County ordinance, and the Airport Manual at their February 6 meeting. Chapter 3 gives general definition of the Airport and specification of the Airport Commission's rule and authority; the Airport Manual provides the rules and regulations of the Airport, defining how operations and business will be conducted on the Airport.

Mr. Cevallos, briefed on February 9, a security incident occurred on the Airport where a 15-passenger van owned by the Civil Air Patrol was stolen from the Airport Terminal's parking lot. Once the Civil Air Patrol filed a police report, the vehicle was recovered within days. As a result of this incident, Mr. Cevallos determined to conduct an audit of the Airport's security to assess all security features and processes. Mr. Cevallos stated that he would use the Transportation Security Administration's (TSA) security guidelines for general aviation airports as the measure to conduct the audit, coordinating the audit through the fixed base operator and other appropriate Airport stakeholders.

Mr. Cevallos report a housing development 13 to 14 townhomes is being proposed at 480 S. Pickens Street. Because the development is approximately 0.8 miles from the end of Runway 13, it raises concerns of compatibility with airport operations. Mr. Cevallos stated while the Airport does not have the authority to stop this development, he has taken steps to collaborate with the County's Legal office, City of Columbia Planning Division, and the developer themselves in order to gain better insight to this specific development, and any future growth that could impact the Airport. In a meeting he attended with the City of Columbia's Planning Director and her staff, it was agreed that verbiage would be provided to the developer to incorporate into their lease agreement an acknowledgement of the Airport, its proximity to the development, and a hold harmless to any noise from the Airport's activities.

Executive Session

An Executive Session commenced at 1:00pm to discuss the status of a future contract for Fixed Base Operator (FBO) services. The Executive Session concluded at 2:20pm. No business was conducted nor votes taken while in Executive Session.

Other Items

Commissioner Parrish wishes to promote the airport in the near future as an event that is coming to Columbia in August has the potential to increase air traffic and revenue for the airport. The Premier Soccer League will be playing at Williams Brice Stadium on August 3,2023. This event is on track to be one of the largest events hosted at the stadium.

Next Meeting

The next meeting of the Airport Commission will be on Monday, May 13,2024 at 12:00 noon.
