Richland County Register of Deeds Recording Requirements & Fees

General Guidelines

The following guidelines are specifically for Richland County and may not be applicable in other counties.

- Names must be typed under signatures to allow for proper indexing.
- All signatures must be original
- Do not include personal identification numbers or account numbers on documents for security purposes.
- If mailing documents for recording, provide a self-addressed stamped envelope for return of original.
- Present documents in correct order to record.
- Use blue ink or black ink on all documents. No highlighting on documents.
- Leave a margin at the top or bottom of documents for the recording label.
- Only one transaction/reference is permitted per document.
- Forms of Payment: Check or Cash. Make checks payable to: Richland County Treasurer
